

Postage costs within Australia – valid from January 2019

A Postage and Handling fee of **AUD \$5 per book** will be charged for all printed PTC notes sent to an Australian address.

International Postage (Airmail Rates) –valid from September 2018

All study notes for overseas students will be sent when the enrolment is received. Please include the overseas postage with your enrolment. Postage rates are in Australian Dollars (AUD).

To work out your approximate postage cost:

1. Identify your postal zone using table 1.
2. Estimate your postage cost using table 2 (Standard Airmail) or table 3 (Express Airmail).

Final postage rate will depend on the actual weight.
